Failure to provide such evidence within three (3) months of signature of this agreement may result in your Training Agreement being cancelled.</p>

Ground School	In accordance with the Training Course Outline, academic instruction to prepare for FAA knowledge test and flight lab training.
Flight Training	Flight training to cover each lesson (first attempt) in the Training Course Outline <ul style="list-style-type: none"> > 43.2 hours of flight instruction/briefings > 15.7 hours in a single-engine aircraft, such as a Cirrus SR20 > 4.0 hours in a Flight Training Device and/or Advanced Aircraft Training Device
Examinations	On-site practical flight test (first attempt) with Designated Pilot Examiner
